### ELIGIBILITY CRITERIA

**Regional Officer** – A member must have been a fully paid up member for 2 consecutive years, held Branch office for 1 year and served as a member of the Regional committee for 1 year. A properly constituted Branch must endorse the nomination.

**National Councillor and Deputy National Councillor** - A member must not hold a self employed service contract with the FSB and must have been a fully paid up member of the Federation for a minimum of 2 years and a member of a Regional committee for a minimum of 1 year and attended at least 50% of the Region's meetings during their last full term of office.
