Category: Contribution to the Community Award

This award is to recognise those enterprises that have "given something back to the local community". The award will go to the business that can demonstrate they have made a committed and proactive contribution to their community in 2009.

The judges will be interested in all the different aspects both individually and through the company they run or in which they are employed including volunteering and corporate social responsibility.

The judges will be looking at what you/they have done and specifically at the outcome. Examples could include charitable activities, providing recreational facilities, working with young people.

Particular attention will be paid to the contribution by your company in terms of time and effort rather than any cash cost to the company.

Question 4 **Contribution to the Community**

What project(s) is your company involved in that has made a positive impact on the local community, economy or environment? Give details of the contribution the project(s) has made.

Question 5 **Legacy/Ongoing Commitment**

Give details of the legacy any existing project(s) is intended to have on the local community and your ongoing commitment.

Question 6 **Future Plans**

Provide evidence (plans, mission statements etc) of any strategy or future projects your company has planned which will make a contribution to the local community, economy or environment.

Question 7 **Influencing Factors**

Explain what influenced you to get involved in making a difference in your local community.

Question 8 **Input Contribution**

Explain what contribution your company has made in terms of time and effort rather than an actual cash input.
