

Did you know that as an FSB member, you are entitled to unlimited access to the FSB Legal Hub, a one-stop shop for legal advice and assistance from experts?

Here's everything you need to know to get you started.

What is the FSB Legal Hub?

FSB Legal Hub is an online service, provided at no extra cost to FSB members.

It is a website dedicated to supporting small businesses, containing more than 430 factsheets and in excess of 750 legal documents and templates, to help with any questions or worries that arise as part of running a business.

The Legal Hub is part of a suite of legal services offered by FSB, which include a Legal Protection Scheme, Employment Protection, Health and Safety Advice and Tax Investigation Protection.

And if there's anything you're not sure about, you can use the FSB Legal Hub in conjunction with a 24/7 telephone advice helpline staffed by qualified barristers and solicitors, who will call you back in an hour.

What's included in the FSB Legal Hub?

Employment: Here you can download customisable employment documentation.

Data protection: Since GDPR came into force, the regulation of personal data has changed. This section assists you with compliance.

Cyber Security: Cyber-attacks are becoming more common. This section explains a company's legal liability for damages in the event of a data breach.

Health and safety: Keeping your business compliant with health and safety regulations is a time consuming and costly process.

To make it easier, here you can download health and safety factsheets and documents including accident reporting, manual handling and risk assessments.

Intellectual property: All ideas you create and legally own are intellectual property. This section provides guidance to businesses and a range of support materials.

Managing my business: There are many aspects of a business to manage. This section includes fact sheets to make it easier.

Property: This section focuses on business regulations pertaining to property, including documentation for dealing with property disputes.

Tax: Taxes are a crucial part of running a business. Here we provide information on how to calculate business rates and tax returns.

Scotland: Doing business in Scotland? Here you can download handy customisable document templates.

Trading and contracts: Here you can find a wide range of editable service contracts and agreements.

Starting a business

In this area you will find documents and guidance around what to consider when starting a business.

Training area

To help get you and your employees up to speed, the hub comes with a free health and safety training area, as well as GDPR training videos.

Frequently Asked Questions

The FAQs section of the Legal Hub contains the answers to questions that are frequently asked on FSB's legal advice line, with a particular focus on employment law.

If you have a question, the helpline has very likely dealt with it before, so it's worth checking it out.
